


# IV. NEW BUSINESS.

A. <u>Proposed Land Purchase</u>.

Mark Fox said there was farmland for sale in the Parshall area for \$11,800.00. If the tribes wanted to be considered in the bid process, they would have to get their bid in immediately. This involves 296 acres of farmland out of a total of 400 acres.

Mr. Gillette said the Natural Resources Committee had met on this and it was their recommendation to bid on it. He said 300+ acres of this is fee patent land, and it is located within the boundaries of our reservation. Mr. Gillette then moved to authorize purchase of this property. Seconded by Mr. Edwin Hall.

Discussion: There was some concern about having enough cash revenue to do this; however, it was decided that the tribes could do this. The tribes would bid \$400.00 an acre.



Motion: Austin Gillette Second: Edwin Hall Vote: 5 for, 1 abstention (Mark Fox), 1 absent. Motion Carried.

Note: Robert Lattergrass entered the meeting at 1:35 p.m.

### B. <u>Gravel Pit</u>.

Edwin Hall requested clarification of legal status of the gravel pit by the Little Shell Pow Wow Grounds. Mr. Kyle Baker was asked to give an account. Mr. Baker said gravel was a surface at the time this pit was dug up, but now it has been made a mineral. He said this pit is owned 100% by the tribes. Mr. Hall said it was his understanding the pit had been locked up for safety reasons, because of the pow wow; and another reason was that someone processed the gravel, but it didn't meet the specifications for chip and seal.

Chairman Mason requested Mr. Baker to do some research on this and find out the exact status on this gravel pit, as far as who has the rights to it, who can use it, etcetera. Mr. Baker said he would do so. He was asked to coordinate this with Ted Danks, Transportation Planning Director; and Virgil Eagle, Roads Department Administrator.

## V. APPROVAL OF RESOLUTIONS.

## A. <u>HUD Resolution for Home Program Application</u>.

Council requested clarification from Mr. Robert Lattergrass on the two amounts submitted for the tribes matching share. Mr. Lattergrass said, after discussions with Mr. John Danks, whom he had been advised to work with, it had been decided to increase the tribes matching fund share so the tribes' scoring points on the grant application would be higher, thereby giving more leverage to the tribes. Gaming revenue was identified as the tribes' source of funds.

Motion for approval of HUD Resolution for Home Program Application was made by Mr. Ivan Johnson, seconded by Mr. Fast Dog.

Mr. Gillette asked about putting some Discussion: wording in the resolution that wouldn't lock the tribes in at 44.5 percent. The difference between the two percentages of 44.5 and 37.5 would be 5 points more on the application. Mr. Lattergrass said 150 residences had been identified somewhat, and there are approximately 75 applications on file, with pictures. Should the grant be awarded, the council will work with the Director of the project to do actual selections based upon need and feasibility. Mr. Gillette said the council would have to look at the past records of home renovations. Chairman Mason advised the criteria could be discussed in the future. A vote was called for.

Discussion: Mark Fox made a recommendation that this resolution include an amendment that would reflect a need for the Tribal Business Council to make final approval of appointment(s) made by Judge Avery, within thirty (30) days after making appointment. Discussion continued on court costs, need for a new detention facility, and other matters.

Chairman Mason requested the annual figure on contract costs spent on the three county jails. Judge Avery said one contract is about \$285,000.00; and she would get these figures immediately. Judge Avery also stated she would have information on the work the consultant(s) had done on criteria for a jail facility, along with the costs of contract jail facilities for the last two years, to be presented at the next Judicial Committee Meeting.


