Edmund Baker recommends each department have an IC Commander and on site director roll falls off and IC Commander roles and responsibilities kick in. Harriet Goodiron review important aspects of the *Tribal Safety Regulatory & Compliance* submitted to the Committee for review. Communication identified as an issue. Councilwoman Monica Mayer recommends a Task Force to bring all parties together to finalize incident plan for spills. Carson Hood Jr. wants spill time response decreased from 3 hours to 15 minutes. Councilman Randy Phelan stated there needs to be a point person with responsibility.
