Letter submitted for the record from Acting Assistant Director of Energy, Minerals, and Realty Management, BLM to Chairman A. T. "Rusty" Stafney of the Assiniboine Sioux Tribe. Government-to-Government consultations concerning two of our proposed rules that affect oil and gas operations on trust and restricted lands. One proposal would rescind the regulations known as the 'hydraulic fracturing rule." e other proposal would postpone certain compliance deadlines in the regulations commonly known as the "venting and flaring" or "waste prevention" rule. By way of background about these initiatives, on March 28, 2017, the President issued Executive Order 13783, entitled "Promoting Energy Independence and Economic Growth," which directs federal agencies to "review existing regulations that potentially burden the development or use of domestically produced energy resources and appropriately suspend, revise, or rescind those that unduly burden the development of domestic energy resources beyond the degree necessary to protect the public interest or otherwise comply with the law." The BLM has reviewed the 2016 Waste Prevention Rule and has proposed a rule that would suspend or delay its implementation until January 17, 2019. 82 Fed. Reg. 46458 (October 5, 2017).
