Mr. Brady requested financial assistance from the committee for this purchase. MM stated to approve this request for \$2,399.99 with a donation from each segment.

*Motion:* Councilwoman Monica Mayer moved to authorize each segment office to contribute to the purchase of the log splitter. Councilman Cory Spotted Bear seconded the motion. Vote: 3-0-0. Motion carried.
