

RESOLUTION OF THE GOVERNING BODY OF
THE THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, the Constitution and By-Laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribes and tribal members; and

WHEREAS, according to Article II, Section I. Membership. The membership of the Three Affiliated Tribes of the Fort Berthold Reservation shall consist of:

- A. All persons whose names appear on the membership of the Three Affiliated Tribes as of October 2, 1974.
- B. Any persons born before the effective date of this amendment and to any member of the Tribe who was a resident of the reservation at the time of birth of said person.
- C. All persons of at least 1/4 degree Indian blood of any federally recognized tribe, and provided at least a 1/8 Indian blood is of the Three Affiliated Tribes (Hidatsa, Mandan, and/or Arikara).

AMENDMENT VII. Dual Enrollment.

- A. Persons enrolled with another tribe and who have received benefits from such tribe in the form of land or payments shall not be eligible for enrollment into the Three Affiliated Tribes of the Fort Berthold Reservation, provided that the inherited interests shall not be considered as being such benefits.
- B. A person eligible for membership with the Three Affiliated Tribes of the Fort Berthold Reservation and another tribe shall relinquish whatever rights of membership he/she may hold in the other tribe as a condition of his/her enrollment with the Three Affiliated Tribes of the Fort Berthold Reservation.

WHEREAS, this amendment became effective 12:00 a.m., December 12, 1975; and

NOW THEREFORE BE IT RESOLVED THAT, the Tribal Business Council of the Three Affiliated Tribes duly and officially enroll Tasha Stephanie Bad Bear, daughter of Mary Ellen (Baker) Bad Bear and Dee Joseph Bad Bear, born July 22, 1980; and

BE IT FURTHER RESOLVED, that Tasha Stephanie Bad Bear, assigned the tribal enrollment number of 301-U-06886, fully meets the enrollment requirement set in Article II, Section I.c., and fully agrees to the enrollment Amendment: AMENDMENT VII. Dual Enrollment.
